5. Pay all applicable fees and performance bonds.

After the resident/contractor has certified that the building project is complete and Section 5 has inspected the construction site and determined that there has been no damage to Section 5 property, the deposit will be returned to the resident/contractor. If, however, there has been damage to Section 5's property, the cost of the repairs will be deducted from the deposit and the remainder of the deposit will be returned to the resident/contractor.
