#### Town Council Update -WSSC Water Main Replacement Project

WSSC's water main replacement project continues in Section 5. The crews have completed work on Windsor Place and areas of Brookville Road, and they are beginning work on Williams Lane.

As a reminder, the Section streets affected include Brookville Road, Connecticut Avenue, Dalkeith Street, Thornapple Street, Thornapple Place, Williams Lane, Windsor Place, and limited parts of Woodbine Street. The purpose of the project is to replace the current water mains that were installed up to 100 years ago and are near the end of their life cycle. This work is similar to the Washington Gas project done in parts of the Section in 2018. Once all the work is completed, the Section will pave the affected streets.

Part of the project requires laying white plastic bypass pipe above ground along the curb line. WSSC puts in special ramps with the pipes along driveways to allow for cars to go over them safely. However, WSSC asks residents to please avoid running over the hoses and the metal fittings coming out of the bypass side. See the photos below for more information. The hose connection is the weakest part of the bypass pipe, and if it is run over, it will leak and likely lead to emergency water shutoffs.

WSSC will place door hangers and post no parking signs when necessary. They try to allow for at least 48 hours notice for planned shutoffs or restrictions. All WSSC Project manager contact information is located on large signs on Brookville Road. Please contact WSSC directly for questions. Due to the nature of the project, they will have the latest information.

#### **New Building Review Consultants**

Section 5 has recently contracted with OIPA, a civil engineering and surveying firm located in Wheaton, Maryland. OIPA engineers, Peter Noursi and Lance Ball, will handle all building application review for the Section taking the place of Joe Toomey. Peter and Lance have worked in a similar capacity with the Town of Chevy Chase since 2016 and recently started work with Chevy Chase View as well. We are excited to welcome them on board and look forward to getting to know them! As a reminder, permit review can, at times, take several weeks, so please be sure to build time into your project schedule to allow for this.




#### Fall Leaf Vacuuming Begins October 17

Leaf vacuuming occurs on Mondays starting on October 17 with the final collection in mid-December.

- \* Leaves should be raked to the edge of the curb, not in the street.
- Please do not place leaves in bags. Take care that limbs, rocks, and any other heavy objects are removed.
- If it rains on our regular vacuuming day, leaves will not be vacuumed that day.

Section 5 will once again offer residents free trees this year to be planted in their private gardens. The Section will plant either small trees such as Redbud or Dogwood, or large trees such as Red Maple or Oak, depending on an owner's preference. The Section arborist, Dr. Tolbert Feather, will assist in choosing and siting the tree. The Section will pay for both the cost of the tree and its planting. The only cost to you will be to water it. The Section will also provide gator bags to assist in watering. The bags help to slowly and evenly deliver a high volume of water directly to the root system of a newly planted tree or shrub with no run-off or evaporation.

The deadline to request a tree is Friday, October 14.

The trees will be planted in November. Please email the Town Manager if you are interested in obtaining a tree.

#### **Trimming Town Trees**

The Section hires a private contractor to trim all Town trees (trees located between the sidewalk and street.) If you believe there is a Town tree that needs attention, please email the Town Manager.

Additionally, Dr. Feather is available to look at both public and private trees at no cost to the resident. Email the Town Manager for more information.

#### Leaf Blower Reminder

Just a reminder about leaf blowers. Please be courteous and thoughtfully choose your work hours, especially on the weekends. As you clear leaves from your property, please take care that you are not transferring them to your neighbors. If you have a lawn service that handles your leaves, please make sure they are also aware.
